### RULES AND REGULATIONS

**Subjects :** 1. DOWRY Custom in 21<sup>st</sup> Century. 2. Role of YOUTH in Anti Dowry Movement. 3. My solutions to eradicate DOWRY Custom from the Society. 4. Effects of DOWRY Custom on women's life. 5. Role of Parents in eradication of DOWRY Custom from the Society.

**Day, Date & Time :** Sunday the 2<sup>nd</sup> December 2018 at 10.00 a.m.

**Venue :** Sathye (Parle) College, Room No.5 Gr. floor, Dixit Road, Vile Parle (E) Mumbai

**Eligibility :** Junior Colleges ( XIth & XIIth ) from Mumbai District (City & Suburbs) can participate by deputing TWO Students The names of the participants be submitted in the prescribed format as per the specimen enclosed duly certified by the College authorities to the effect that he / she is a bona fide student of the College.

**Submission of Entry Form & Fee :** The prescribed Entry Form along with format giving the details of the student representatives and ENTRY FEE of Rs.50/- be submitted to the above address on or before 2.12.2018. Entries will be accepted at the venue as a very special case.

**Language & Duration of the Speech :** The student participant may speak either in Marathi, Hindi or English and the duration of the speech will be five to six minutes. The participant will not be allowed to read out his / her speech but may however refer to the points written on a small piece of paper.

**Prize Scheme :** AKKA OAK ROTATING TROPHY will be awarded to the winning College from Junior Group. The student First in order of Merit will be awarded a Cash Prize of Rs.1000/- with Merit Certificate. There will be additional two Cash Prizes of Rs.500/-, & Rs.250/- to those who stand 2<sup>nd</sup> & 3<sup>rd</sup> in order of merit respectively. Certificate of Merit will be awarded to first ten in order of merit & Participation Certificate will be given to all.

**Evaluation :** The Evaluation will be on Individual basis and not on Team basis. The points of evaluation are : (1) Grasp of the Subject (2) Presentation of the Subject (3) Eloquence (4) Summarization & (5) Effect on the Audience.

**General Conditions :** The organization shall nominate a Panel of Judges to evaluate the competition and their decision regarding the Result of the Competition shall be final and binding on all concerned. The decision in respect of all the aspects of the competition shall be final & can not be questioned in any Court of Law or before any other Authority.
