INTER COLLEGIATE SHORT FILM COMPETITION RULES AND REGULATIONS

Anti Dowry Movement, Bombay announces Inter Collegiate Short Film Competition for students of Degree Colleges from Mumbai Districts (City & Suburb) affiliated to University of Mumbai on the occasion of ANTI DOWRY WEEK on the subject of "DOWRY" with special focus on following points : (1) DOWRY Custom : A Burning Problem. (2) Evil effects of DOWRY Custom on Women's Life. (3) Increasing Graph of Suicides & DOWRY Custom. (4) Who is responsible for Evil Custom of DOWRY ? (5) Role of YOUTH in Anti Dowry Movement.

DAY, DATE & TIME : Monday the 10th December, 2018 from 10.30 a.m. to 5.00 p.m.

ELIGIBILITY : Students from Degree Colleges (all faculties except B.Ed. & B.P.Ed.) from Mumbai (City & Suburb) can participate by submitting one short film per team of three students and not more than three short films from one College. The short film may be either in Marathi, Hindi OR English and the duration should be not more than 5 minutes (300 seconds) including the beginning and end credits. Films exceeding this time limit are liable to be rejected. The entries can be short digital animation films too on any of the above topics. Details such as Name of the participant, College, Class, Roll No. and subject-topic be given in the beginning of the film. **ENTRY FEE :** Nominal Entry Fee of Rs.100/- payable by the College either in Cash OR Cheque which may be drawn in favour of Anti Dowry Movement, Bombay. (Fee per College & not per film/team)

SUBMISSION : Short Film in proper format e.g. pendrive / VCD should be submitted along with Entry Form duly signed by the College Authorities on Monday the 10th December 2018 to us at our above address, from 10.30 a.m. to 5.00 p.m. **COPYRIGHT :** The Short Film must not contain any copyrighted work(s) belonging to third parties unless (1) participants have a license to use such works in the film or (2) the use participants' film makes of such works is a fair one under the copyright laws. Participants will retain any licenses and provide them to organizers upon request. The entry should be submitted by the participant who may be the rights holder of the film. For the purposes of this competition and subsequent distribution of the said film, the participant hereby confirms that he/she has the necessary rights to submit the entry & accepts the terms. **EVALUATION :** Short Films will be evaluated on following points (1) Grasp of the Subject (2) Presentation of the Subject (3) Dialogue / Language (4) Message departed (5) Effect on Viewers. Examiners will be appointed by the organizers and their decision regarding the result of the competition shall be final and binding on all concerned and will not be questioned in any Court of Law or before any other authority. **PRIZE SCHEME :** The winning Short Film FIRST in order of merit will be given Cash Prize of Rs.5000/- and SECOND & THIRD in order of merit Rs.3000/- & Rs.2000/- College selected for the BEST Short Film will be awarded ROSHANLAL TALWAR TROPHY. Result will be declared on 31st Dec. 2018. Prizes will be distributed on 12th January 2019 in a special function on the occasion of YOUTH DAY.
